 - a) Care should be taken to avoid the collection & disposal of the important documents of the bank.
 - b) Scrap and old paper of the bank to be sold only to the paper pulp company and same should be agreed legally on the stamp paper of **Rs.200/-.**
 - c) Any misuse of banks document by contractor will be liable for prosecution.
 - **d**) Scrap should be collected from various premises by weighing/counting in presence of concern officer, and the amount of said scrap should be deposited in the bank immediately by D.D. or Cash.
 - e) Interest free security Deposit of **Rs.5,000/-** should deposited in the bank for the period of 01-01-2022 to 10-01-2022.
 - **f**) Required permissions should be taken from concern dept., while collecting the scrap.
 - **g**) Rates should be inclusive of all taxes and transportation.
